 -FVRCP  
 -Rabies  
 -Proof of a negative FELV/FIV test  
 We also recommend using a flea and tick preventative

**Boarding Cancellation policy:** 72 hours notice before the reservation is required for cancellations; if less than 72 hours, a cancellation fee will be incurred.

I agree to assume full financial responsibility for any and all expenses incurred as a result of their actions. I understand that Paws Unlimited Inc. staff is expected to make a reasonable attempt to contact me before incurring such expenses, that they may need to incur such expenses if they can't reach me, and that an emergency situation could arise where it would not be feasible for them to contact me before the expense is incurred.
