Boarding Rules and Requirements

All dogs should be in good health, free of communicable diseases and written proof from a veterinarian of these current vaccinations is required:

- Distemper and Parvo (sometimes called the 5-in-1 shot DHLPP or DA2PPV)
- Rabies
- Bordetella (canine cough). Bordetella must be administered within the past 12 months and no sooner than 10 days prior to your pet's visit.

We also recommend using a flea and tick preventative

Boarding Cancellation policy: 72 hours notice before the reservation is required for cancellations; if less than 72 hours, a cancellation fee of \$35 will be incurred.

Dogs' owners are financially responsible for any damage or destruction to the kennel enclosure caused by their pets.

Liability Waiver

I agree that if I or any of my associates get injured by an animal at Paws Unlimited Inc, I will not hold Paws Unlimited Inc. liable for any injuries or damages that may occur.

I have disclosed to Paws Unlimited Inc. all known risks, dangers, and medical conditions associated with my dog(s). I understand that I am solely liable for medical care expenses and damages that result from injuries caused by my dog, or that I will resolve the matter directly with the owner(s) of the other dog(s) based on applicable laws. I understand that Paws Unlimited Inc. may refuse service to my dog for any reason it deems necessary, including but not limited to, overly aggressive behavior, overly excessive barking, and illness. I agree that there are inherent risks in sending my dog to any dog boarding kennel, such as illness or injury, and I accept these risks because they are outweighed by the benefits. Paws Unlimited Inc. will not be liable for any illness or injury that may occur to my dog(s).

I authorize Paws Unlimited Inc. to take actions they deem as necessary to ensure the health, well-being, and safety of my dog(s), and to take reasonable action to resolve any medical problems that may arise while my dog(s) is in their care. I agree to assume full financial responsibility for any and all expenses incurred as a result of their actions. I understand that Paws Unlimited Inc. staff is expected to make a reasonable attempt to contact me before incurring such expenses, that they may need to incur such expenses if they can't reach me, and that an emergency situation could arise where it would not be feasible for them to contact me before the expense is incurred. I understand that, as is the norm in the pet care industry, under no circumstances will Paws Unlimited Inc. be liable for damages beyond the replacement value of my dog(s). I waive all claims or actions against Paws Unlimited Inc., relating to the care, control, health, and/or safety of my dog(s) arising while my dog(s) is in their care.
